## **NOTICE OF PROTEST HEARING**

### **PROPOSED CITY OF SANTA CLARITA ANNEXATION NO. 2002-09A (STONECREST)**

Pursuant to Government Code section 57025, *et seq.*, the Local Agency Formation Commission for Los Angeles County (“LAFCO”), hereby gives notice as follows:

1. LAFCO has assigned the following short form designation to this proceeding: “City of Santa Clarita Annexation No. 2002-09A.”
2. The exterior boundaries of the proposed annexation are set forth in Exhibits A and B of the Local Agency Formation Commission for Los Angeles County Corrected Resolution No. 2006-02RD Making Determinations and Approving the Proposed Annexation of the City of Santa Clarita, adopted on March 22, 2006 (the “Corrected Resolution Making Determinations”).
3. This project consists of the annexation of Los Angeles County territory to the City of Santa Clarita. The subject territory encompasses approximately 409.4 acres of inhabited territory identified in the attached map (City of Santa Clarita Annexation No. 2002-09A “Exhibit A”). The City of Santa Clarita Annexation No. 2002-09A is subject to the terms and conditions set forth by LAFCO in the Corrected Resolution Making Determinations, available at the LAFCO offices at 700 N. Central Avenue, Suite 350, Glendale, CA 91203 (818) 254-2454, and at LAFCO’s website, <http://lalafco.org/>.
4. As set forth in the proposal submitted to LAFCO, the reason for the proposed annexation is: The annexation request was initiated by the City of Santa Clarita at the request of a majority of area residents and to promote sound planning and achieve orderly growth.
5. You are hereby notified that LAFCO will hold the Protest Hearing for the City of Santa Clarita Annexation No. 2002-09A, on Wednesday, June 28, 2006, at 9:00 a.m., in the Board of Supervisors Hearing Room (Room 381 B), Kenneth Hahn Hall of Administration, 500 West Temple Street, Los Angeles, CA 90012.
6. Written protests against the City of Santa Clarita Annexation No. 2002-09A may be filed beginning on March 30, 2006, the date of publication of the Notice of Public Hearing and thereafter, to the conclusion of the Protest Hearing. Only written protests signed and dated on or after March 30, 2006, and received before the conclusion of the Protest Hearing, will be counted toward the protest.
7. Protest forms are available at the LAFCO offices at 700 N. Central Avenue, Suite 350, Glendale, CA 91203 (818) 254-2454, and at LAFCO’s website, <http://lalafco.org/>. Please use the *Protest Form – City with over 100,000 Residents*. Written protests may only be submitted by any registered voter and/or owner of land within the annexation area and must be dated and include the following information: (1) a concise statement that you are opposed to City of Santa Clarita Annexation No. 2002-09A, (2) printed name, signature, address (street, city, state and zip code), mailing address, if different and date. All signatures without a date or bearing a date prior to March 30, 2006 shall be disregarded for the purposes of ascertaining the value of written protests. Written protests may be mailed in advance of the hearing to LAFCO at 700 N. Central Avenue, Suite 350, Glendale, CA 91203 or filed at the hearing.
